Action and Discussion Items

1. **Summary from last meeting** – summary acceptable; no comments were received.
2. **IDDE poster series finalized drafts from NCTCOG** – NCTCOG received good feedback on the needs of the posters. NCTCOG will provide finalized posters before next IDDE Task Force meeting in a form that is editable.
3. **FY2016 Projects & Trainings– Preliminary Discussion** –included FAQ sheets for fish kills and potable water as identified by Regional Stormwater Management Coordination Council.
 - **IDDE Dry Weather Screening Workshop** Feedback – NCTCOG discussed comments and feedback received by participants. Participants also expressed an interest to have additional remedial training, Task Force responded that future trainings to include breakout sessions into small groups based on experience.
 - **Industrial Inspector Workshop** – discussion focused on where to hold the training and what time of the year would this training be held. Task Force decided that it would be best to hold training early spring and if possible, have the training at two different locations for morning and afternoon sessions. NCTCOG is following up with Task Force members to find locations. Possible locations include Progressive Waste facilities and McKinney National Airport.
 - **Advanced IDDE Training** – NCTCOG discussed Advanced IDDE training and the need to develop an agenda. The Task Force noted that this will be the first time this training will be offered and the training agenda needs to identify what is a priority for this training. Task Force asked to review the draft agenda and provide comment before contacting presenters and finding a location to host the training.
