Task 3 – Provide data on methods to set up a public/private partnership. Provide recommendations on when/where regional detention is most appropriate. The research will begin in October and provide research to the subcommittee at the January meeting.

Task 4 – Research natural channel and volumetric detention guidance in existing criteria manuals to see where iSWM could be improved. The research will begin in October and provide research to the subcommittee at the January meeting.

Task 5 – Review rainfall depths and percentiles that other Texas cities are using to treat water quality. Use updated rainfall data to calculate regional percentile storm events. The research will begin in October and provide research to the subcommittee at the January meeting.

Task 6 – 2-hour training for design and maintenance of BMPs – Early December 2020 Outreach & Implementation Strategy

- Working on the plan document outline
- Interview with David Hunter, City of Denton, July 2020.

Task 7 - Provide details and specifications for up to 5 water quality, filtration, and infiltration BMPs from the Site Development Controls. Draft details and specifications will be available at the next subcommittee meeting. During that meeting, the group will discuss the desired purpose of the specifications. The subcommittee decided to review the drafts at the January meeting before making a final decision.

4. **Subcommittee Roster Updates.** NCTCOG staff will present the FY2021 roster, a strategy for growing iSWM Implementation Subcommittee (IIS) membership, and an optional vice-chair vote. The subcommittee discussed strategies to grow membership and participation. The strategy consists of reaching out to the iSWM communities that were part of the licensing agreement, Certified iSWM communities, and attendees that consistently attend meetings. Concerns

This might discourage communities from attending because the subcommittee works on updates to the manuals, among other important tasks. The discussion concluded with members agreeing that the subcommittee would like to see the group grow. The FY21 roster will be attached to the summary. At the January meeting, the subcommittee will discuss the roster's purpose and how to move forward.
