*The City of Arlington presented on tracing mysterious blueish-green water, and a white foaming substance in Crystal Canyon. Arlington staff determined that the color and white foam were due to natural geochemical reactions.*

5. **Roundtable Topics.** The IDDE Task Force members and NCTCOG staff will share additional items as time allows.

The City of Arlington – The city asked the group if other cities are experiencing an increase in calls citizen complaints. The city is also working towards bringing a high-risk industrial program online within the next year.

The City of Plano – The city is also experiencing a higher influx of calls. City stormwater staff are also working to fix an SSO at the Circle K and a crack in their water line. TCEQ is now involved and is working with the Circle K owners to remediate the spill, and Plano construction crews are working to patch the waterline.

The City of Carrollton – The city is also experiencing an increase in citizen complaints and reports about grass clippings.

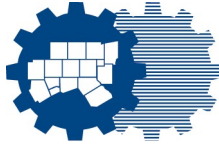
The City of Fort Worth – The city is working towards finishing their annual stormwater report.

The City of Dallas – Has also seen an increase in lawn waste, and members of the Cities Spill Response Mitigation team are working with the cities stormwater monitoring team.

Many other cities on the call reported an increase in citizen complaints and lawn waste.
