- **It's Time for Emergency Managers to Prepare for the Fragility of Electric Power Grids** - Michael Lambert, Houston-Galveston Area Council of Governments
 - **Pathways to Disaster**
 - Failure of imagination
 - Inability to suspend disbelief
 - "Whistling past the graveyard"
 - Misplaced confidence
 - "Someone else's problem"
 - Electricity is the bedrock of our modern society
 - The grid that brings us our electricity is FRAGILE
 - We need to recognize, embrace, plan and prepare for that fragility
 - Review of the 2021 winter storm and the impact it had on the grid, timeline of what happened.
 - Key takeaways:
 - The grid did NOT collapse
 - It was a generation problem
 - The intermittents did not cause the problem but they did not help
 - Once the incident began, there was nothing grid operators could do to stop it
 - Basic stuff to know:
 - Electricity supply and demand MUST be balanced
 - Electricity cannot be easily stored in utility-scale quantities
 - It is a system of systems
 - The grid is inherently unstable
 - Overview of how the grid works:
 - Generation, transmission and distribution
 - Threats to the grid:
 - Nature
 - Cyberattack/sabotage
 - Physical attack
 - Electromagnetics
 - Its own structural challenges
 - Things to think about:
 - Is a long-duration, wide-spread power outage part of your
